

## **What This Privacy Policy Covers**

- This policy covers how Gateway Gay Rodeo Association (GWGRA) treats personal information that GWGRA collects and receives, including information related to your past use of GWGRA products and services. Personal information is information about you that is personally identifiable like your name, address, email address, or phone number, and that is not otherwise publicly available.

## **Information Collection and Use**

### **General**

- GWGRA collects personal information when you register with/become a member of GWGRA , when you use GWGRA products or services, when you visit GWGRA web pages.
- When you register we ask for information such as your name, email address, birth date, gender, full address, zip code, occupation, industry, and personal interests.. Once you register with GWGRA or sign in to our services, you are not anonymous to us.
- GWGRA collects information about your transactions with us and with some of our business partners.
- GWGRA automatically receives and records information on our server logs from your browser, including your IP address, GWGRA cookie information, and the page you request.
- GWGRA uses information for the following general purposes: fulfill your requests for products and services, improve our services, contact you, conduct research.

### **Children**

- GWGRA membership or registration does not allow persons under the age of 18.

## **Information Sharing and Disclosure**

- GWGRA does not rent, sell, or share personal information about you with other people or nonaffiliated companies/organizations except to provide products or services you've requested, when we have your permission, or under the following circumstances:
  - We provide the information to trusted partners who work on behalf of or with GWGRA under confidentiality agreements. However, these companies do not have any independent right to share this information.
  - We respond to subpoenas, court orders, or legal process, or to establish or exercise our legal rights or defend against legal claims;
  - We believe it is necessary to share information in order to investigate, prevent, or take action regarding illegal activities, suspected fraud,

situations involving potential threats to the physical safety of any person, violations of GWGRA 's terms of use, or as otherwise required by law.
